FULL TERMS AND CONDITIONS

These Terms govern the Promotion and apply to all persons (referred to as "you" or "your") who are eligible to participate on behalf of an eligible business. Mercedes-Benz UK Limited ("Promoter", "we", "us", "our") is a company incorporated in England and Wales with registration number 2448457, whose registered office is at Tongwell, Milton Keynes, MK15 8BA.

1. THE GIFT

- 1.1** Two hundred and fifty (250) Gifts are available in total. Each Gift consists of one (1) official Mercedes-Benz branded baseball cap.
- 1.2** Gifts are available to the first two hundred and fifty (250) eligible applicants who are successfully approved as PartsPro Trade Members and will be allocated on a first-come, first-served basis according to the date and time of approval. The Promoter reserves the right to substitute the Gift with an alternative item of equal or greater value if it is necessary to do so.
- 1.3** There is no cash alternative. The Gift is not negotiable, transferable, or exchangeable.
- 1.4** Gifts will be dispatched to the eligible applicant's registered business address as provided in the Trade Member application. The Promoter (or the Administrator acting on behalf of the Promoter) accept no responsibility for Gifts that are lost, delayed, or not received due to circumstances outside their reasonable control.
- 1.5** The Promoter (or the Administrator acting on behalf of the Promoter) shall not be responsible for the condition, completeness, or content of the Gift once dispatched. Any queries regarding the Gift should be directed to the contact details in section 10.

2. PROMOTION PERIOD

- 2.2** Applications submitted before the Opening Date or after the Closing Date are automatically ineligible for the Gift and/or Prize Draw (as applicable).

3. ELIGIBILITY

- (c) submit a complete and valid application during the Promotion Period and are approved as a Trade Member.

3.2 Applicants must submit the application through an authorised representative who is aged 18 or over and has authority to act on behalf of the relevant business.

3.3 The following are not eligible to participate:

- (a) employees (and their immediate family members) of Mercedes-Benz UK Limited, OEConnection Limited, authorised PartsPro Retailers, and any agencies or third parties directly involved in the administration or operation of this Promotion;
- (b) businesses that are motor factors, parts suppliers, vehicle manufacturers' wholly-owned dealer groups, or direct subsidiaries of an OEM; and
- (c) businesses that have previously held membership of the PartsPro Trade Programme.

3.4 By entering this Promotion, you confirm that your business meets the eligibility criteria. The Promoter and/or the Administrator acting on behalf of the Promoter may require you to provide evidence of eligibility.

3.5 The Promoter and/or the Administrator acting on behalf of the Promoter may reject applications that are:

8. DATA PROTECTION AND PUBLICITY
